Auditor's Report
Year 1927

At the request of Mr. George P. Castle President of the Board of Trustees of Kawaiahao Church I have audited the accounts of the Treasurer Mr. Albert Waterhouse, for the year 1927 and wish to report thereon as follows:

I have compared the cash disbursements with the cash vouchers on file and found same correct.

I have compared the segregated amounts of money which were turned over to the Treasurer from the Kawaiahao Church office, as per receipt book, with the entries in the Treasurer's book and found that all money has been accounted for. In reference to the segregations, I found that Baptismal Certificates are included in Sundry Office Receipts, New Budget is included in Collections, and in September 25¢ was credited to General Collections instead of Cemetery Account.

I have checked over the stubs of the receipts given, for the Restoration Fund, directly to the Treasurer, and found same correct.

I have checked over the amounts received regularly each month from different sources and found same correct.

I have checked over, as far as possible, the various other amounts of money received by the Treasurer direct, and found same correct.

I have checked all postings and additions in order to verify the General Ledger Accounts and found same correct.

I have checked the Trial Balance as of December 31, 1927, before and after closing, and found same correct.
